CIRCULAR - COVID PROTOCOL MEASURES

- 1. It is mandatory for the students to install the AarogyaSetu App and to keep Bluetooth and Location app in the ON mode, at all times during their stay.
- Students are required to follow the rules laid down by the Government of Kerala with regard to COVID PROTOCOL measures as regard to quarantine and tests.
- 3. Atleast one dose of vaccination is mandatory to be permitted to the campus.
- 4. Students are required to submit
 - a) Letter of consent from Parent / Guardian & Self-declaration form on the first day of reporting to the Institute (uploaded on the website) –Annexure II.
 - b) Vaccination Certificate of atleast one dose.
- 5. For all those who stay in the Hostel, Covid -19 negative certificate (RT-PCR) obtained within 72 hours prior to the date of entry at the institute is mandatory.
- Self-monitoring of health must be done by all and any illness must be reported at the earliest to the class coordinators. Asymptomatic students only will be allowed inside the campus
- 7. Student vehicles are **NOT** allowed inside the campus.
- 8. Thermal scanning will be done at the entry points.
- 9. Hands must be sanitized at the entry points and as required.
- 10. Co-operate with the security personnel to complete the necessary formalities with regard to thermal scanning, sanitization and security check.
- Use of face covers/masks is mandatory.
- 12. Sneeze and cough etiquette must be followed.
- 13. Physical distancing of at least 6 feet is to be followed.

- 14. Students are to report directly to the respective departments as per time table only at the scheduled time.
- 15. Students are not permitted to gather in common areas.
- 16. Minimize movement in the campus and main building. Students will not be allowed to roam inside the campus (e.g. Academic area, Library, Computer Lab, etc.) without justified reasons.
- 17. No personal enquiry to be made at the Academic Office/Administrative office. Any enquiries may be done through email (principal@ihmctkovalam.org) which will be responded in 1 days' time (working day).
- 18. Day scholars are not allowed to stay in the campus after their class timings
- 19. Day scholars are prohibited from entering the hostel
- 20. Students attending Food Production Practical are required to bring tiffin box to carry back the food prepared in the session.
- 21. No Lunch service. Students are to avoid sharing of food and beverages with others.
- 22. All students are requested to bring their own water bottles which can be filled from the Institute.
- 23. It will be the responsibility of the student and parents to ensure compliance to all the rules/regulation related to COVID-19 protocol.
- 24. Violation of the COVID 19 protocol is punishable as per the Disaster Management Act. The Institute will not be responsible for the Consequences.
- 25. The Institute reserves the right to expel any student from the Hostel if the student does not follow the above rules and other restrictions/advisories issued by Government of India / Govt. of Kerala/ Institute.
